Agenda Item 7.1. Finance Update

Mr. Markey presented the financials for the month ending 9/30/2022. Atmosphere's enrollment was 1,108. Atmosphere has demonstrated revenue growth from prior years. At the end of September, Atmosphere's cash position was \$2.1 million. Mr. Markey went on to present the budget vs. actual document which shows Atmosphere's expected revenue and expenditures versus what was actually received or paid out.

Atmosphere received the outstanding lease assistance from the DOE in per pupil 3. At this point, Atmosphere's current enrollment has seemed to plateau around 1,110, but they continue to recruit students.

The board asked what Mr. Markey predicts in terms of year end cash. Mr. Markey noted that this number was in the range of \$600,000, but he will have a deeper analysis this week.

Mr. Markey also updated the board on the outstanding grants. Title 1, Title II and Title IV is 20% of the allocation not yet received by Atmosphere. Mr. Markey expects to receive this within the

next two months. Ms. Markey is escalating certain grant payments to ensure that they are received soon, as they were submitting for approval a month ago.

Agenda Item 7.4. 2022 NYS Test Results

Ms. Lena Litvak presented Atmosphere's 2022 NYS Test Results. Atmosphere did very well in English and hit record highs for all grade levels in proficiency and proficiency level. This means the entire grade level average has gone up, rather than just the students with the highest academic scores. This is a key takeaway from the English Exam. While Atmosphere's Math scores went down, New York City's scores went down much further, showing that Atmosphere students did not regress as much as students across the city.

In 8th grade, Atmosphere scholars increased the scoring gap between themselves and other students in District 10 on the English Exam. Ms. Litvak noted the same change in 6th and 7th grade.

The board noted that the NYC DOE may not have taken enough steps to mitigate learning loss and run as much of a real school program as possible during remote learning. Atmosphere was able to make greater strides in recreating the classroom over Zoom and provide great instruction, even if it was not in person. The board commended Atmosphere administrators and teachers on their efforts during COVID, and noted that the state exam scores are a testament to the hard work that went into building the academic program.

On the English exam, the proficiency level average across grade levels demonstrates that most students are increasing proficiency level, not just the highest performing students. Ms. Litvak noted two subgroups that went up by 20%. Students with IEPs went up by 22% in terms of proficiency. African American students went up 22% in terms of proficiency. Atmosphere reached a record level of 6th and 7th grade students who got at least 60% of multiple choice questions correct on the English State Exam. The same goes for 6th and 8th graders on constructed response. Atmosphere scholars are outperforming NYC in writing proficiency.

This school year Atmosphere will spend more time breaking down data by question type to see if there is a trend around performance. Based on Ms. Litvak's initial observation, there is no clear trend, but the questions will be broken down further to determine why some students are succeeding and why some are struggling with certain key elements. For example, some students may struggle with central idea, and some may excel.

In Math, Atmosphere's overall proficiency level decreased but New York City's proficiency level decreased much further. It was noted that the SY 21-22 state exam was the first experience with the state exam due to COVID-19. Many of Atmosphere's scholars, especially 6th graders, came from DOE schools where learning was largely interrupted for two years. Ms. Litvak shared a brief summary of subgroup levels in the Math State Exam. For example, females and economically disadvantaged students decreased in proficiency by more than 10%. Ms. Litvak also displayed a breakdown of question types and how scholars performed on each type.

The board asked how we are doing so far this year. Ms. Litvak noted that the scholars have an exam coming up that will provide more data for her to share with the board in late November. This will show Atmosphere staff members where efforts need to be further focused to ensure improvements in proficiency.
