#### Agenda Item 6. MS Achievement Update

Atmosphere's Achievement Director, Lena Litvak, reviewed the following trends with the Board:

- The MS achievement midline tests have been updated and revised to align with new testing structures from NYSED, including computer-based testing and question allocations by question type and question format.
- Results from the midline predict that students are on track to match past expected performance, but that more work is needed to strengthen the probability of this outcome and perhaps exceed the goal.
- Scholars have done well with computer based testing and have not seen a negative impact from its implementation, which is not the case at all schools around NYS.
- Achievement lessons and scope and sequence have had to evolve to match CBT and the new number of questions in each category.
- The key post-midline actions steps have included creating bubble data groups and more sprints to accelerate and measure growth between now and the state test.
- Saturdays are starting this weekend March 1st.
- After school sessions are for scholars that do not show up to their assigned Saturdays.

Michael Lagas asked about 6th graders that came from schools other than Atmosphere and if we know how they took the test in their former school. Lena Litvak responded that we don't know the format used in their prior school, but we do know what their skill level is and when they started in the atmosphere.
